- 1. Information We Collect: We may collect and store the following information from our customers and supporters:

We only collect data that helps us achieve the purpose set out in this Privacy Policy. We will not collect any additional data beyond the data listed above without notifying you first.

- 2. Purpose of Data Collection: The purpose of this privacy policy is to inform users that we collect your information to:

 - 2. Send updates, newsletters, promotions, and special offers to enhance your experience with Fresh Routes.
 - 3. Improve our products and services by analyzing customer feedback and preferences.
 - 4. Comply with legal and regulatory requirements.
- **3.** Data Sharing and Disclosure: We do not sell, trade, or share your personal information with third parties without your explicit consent, except in the following cases:
 - To our trusted partners and service providers who assist us in operating our business and providing services to you.
 - If the law requires it and/or if it is required for any legal proceeding.
 - To prove or protect our legal rights.
 - To buyers or potential buyers of this company in the event we seek to sell the company.
- **4. Consent and Control:** By providing your personal information, you consent to our collection, use, and disclosure practices as outlined in this Privacy Policy. You have the right to withdraw your
